### **About Dr. David C. Malloy**

David C. Malloy, PhD, is a Western alumnus having obtained both his Bachelor and Master degrees from Western's Faculty of Physical Education. He received his doctorate from the University of Ottawa in Educational Administration.

He enjoyed a 30 year career with the University of Regina, both as a faculty member and administrator, most recently as the Vice-President, Research since 2013. Previously at the University of Regina he has held positions as Assistant Dean of the Faculty of Kinesiology & Health Studies, Associate Dean in the Faculty of Graduate Studies & Research, and Associate Vice-President (Research).

Dr. Malloy also continued teaching at the University of Regina as a Full Professor in the Faculty of Kinesiology and Health Studies and as associate member in the Department of Philosophy. He has maintained an active research portfolio with a focus on applied philosophy in health care. His interests include ethical decision-making, codes of ethics, existential hardiness, personhood, and ethical climate/culture.

Throughout his academic career, Dr. Malloy has published six books, 67 peer-reviewed articles, contributed to three book chapters and seven book reviews, given 81 conference presentations, and has received more than \$4.5 million dollars in team and individual research grants. He has served as an adjudicator for both SSHRC and CIHR, and occupied the role of the University's SSHRC Leader.
