- Part time students taking half courses unevenly weighted over both terms, fees are due in the corresponding term the courses are taken.
- Payments can be made by cheque, bank draft, money order, online/telephone banking, debit card, credit card or electronic wire transfer. See the Payment Methods section of our website for more information.

- All students attending King's/Western for the first time are assessed a \$35.00 fee for a student card.
- Withdrawal, Cancellation and Refund information can be found in the Refund/Withdrawal Section of the Money Matters Page on our website.
- Students offered late admission to King's are given 10 business days to make their 1st payment before late fees are charged
- Late payment fees will be applied to all payments received after the due dates specified above; See late fee chart below
- King's University College reserves the right to withdraw students from their registered courses and residence for non-payment of fees and request pre-payment in advance to enrollment.
- While every effort has been made to ensure the above schedule is complete and accurate, King's University College reserves the right to make adjustments as required.
