Course description: The main objective of this course is for students to learn about theories, institutions, and recent trends in international finance. To that end, the topics covered include the balance of payments, exchange rate systems and theories of exchange rate determination, and other topics related to open economy macroeconomics.

Course learning outcomes:

1. Understanding the balance of payments.
2. Understanding exchange rate systems and theories of exchange rate determination.
3. Learning about fiscal and monetary policy in open economies.
4. Learning about international economic institutions and their roles in the world economy.
5. Learning about different types of international financial crises.

Mode of Instruction: in-person

Course textbooks/materials:

I will base my notes on chapters from *International Economics* by James Gerber (7th and 8th editions). You do not need to purchase the textbook, but you may refer to it for further reading. **You will be tested based on your understanding of what's covered in class and any extra material that I may provide (like slides, readings, exercises, and so on).**

Method of evaluation:

The course grade will be based on attendance (5%), 4 quizzes (15% each for quizzes 1 to 3 and 10% for quiz 4), and a comprehensive final exam (40%). Assessments may include a mixture of true/false, fill in the blank, multiple choice, numerical, and/or short essay questions.

1. Academic Accommodations, Consideration for Absences

Academic Accommodation (Accessibility)

Academic Consideration for Student Absence

If a student is unable to meet a course requirement due to substantial but temporary extenuating circumstances (medical or compassionate), they should follow the procedures below.

Students are permitted one academic consideration request without supporting documentation per term per course.

Absences from Final Examinations

If you miss the Final Exam, contact the Academic Advising Office of your faculty/college of registration as soon as you are able to do so. They will assess your eligibility to write the Special Examination (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a “Multiple Exam Situation” (e.g., more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred.
