Mode of Instruction: In Person

An introduction to econometric description and inference which covers: descriptive statistics for cross-section and time-series samples; probability, discrete and continuous probability distributions, random variables; estimators and sampling distributions; confidence intervals and tests of hypotheses; simple linear regression for normal and non-normal populations.

Course description:

An introduction to econometric description and inference which covers descriptive statistics for cross-section and time-series samples; probability, discrete and continuous probability distributions, random variables; estimators and sampling distributions; confidence intervals and tests of hypotheses; simple linear regression for normal and non-normal populations.

Course learning outcomes:

At the end of this course students should be able to: (i) interpret tables, graphs, and statistics used for describing data; (ii) apply probability theory to model random variables; (iii) estimate population parameters using point and interval estimators; (iv) evaluate and describe the properties of an estimator; and (v) test theories about population parameters (determine an appropriate test statistic; implement a formal hypothesis test and interpret the outcomes).

Mode of Instruction: (*in-person, online synchronous, online asynchronous, blended*)

This course is taught in-person. It is expected that students will attend all lectures and labs. Teaching material and announcements will be updated weekly on OWL. It is your responsibility to check them regularly.

Method of evaluation:

- **Participation/Attendance** (iClickers/Socrative=5%) **5%**
- **Math Quiz** **5%**

IMPORTANT NOTES:

- **Students get a minimum score of 40 in the final exam to pass this course.** Students who miss the midterm test must obtain academic accommodation to have the weight transferred to the final exam and they need to pass the final exam in order to pass this course. For students who get min 40 in the final exam, the final exam weight may be up to 50% if their final exam is higher than the midterm. However, the final exam weight cannot be transferred to the midterm in the event you do not get the min. 40 in the final exam, the maximum grade in this course will be 49% and you will not receive course credit.
- Students will have **72 hours** after the due date to submit assessments without penalty.
- If a student misses the late deadline, a mark of 0 will be automatically applied to the missed assessment.
- The **math quiz** is pass or fail. Students who fail the math quiz may retake it after going through the results, possibly through a math workshop. Details to follow.
- If the final exam score is higher than the midterm score, 10% of the midterm weight will be transferred to the final making the final worth 50%. Weight will not be transferred from the final to the midterm if the midterm score is higher because the midterm is not comprehensive.

Academic Considerations:

- **Homework** (Best 3 out of 4)
 - The missed homework deadlines have built-in flexibility to submit without penalty 72 hours past the due date. There are no makeups or accommodations for these. It is best to try and submit by the official due date.
- **Participation and attendance**
 - The participation grade component will be calculated as follows:
 - If a student participates in 80% or more of the clicker questions, they will receive full marks.
 - If a student answers less than 80% of all clicker questions, the clicker mark will decrease linearly using the formula: **Clicker mark = 6.25(y)**, where y is the proportion of all iClicker/Socrative questions the student answered.
 - *For example, if you answer 70% of the clicker questions, you will have $0.70 \times 6.25 = 4.375$ marks towards your participation / attendance grade component.*
 - Students may miss 20% of classes and still receive the full mark. Because of this built-in flexibility, here are no makeups or accommodations for missed participation\attendance marks.

- Students should use their mobile devices (instead of laptops, etc.) when participating as GPS settings will be used with the software. Students will be assigned a participation grade only and must attend class to receive the grade.
- Students who are participating with iClicker or Socrative AND are not present in-class (i.e., falsifying attendance and participation) will automatically receive a grade of 0 for the in-class participation course grade component.
- *Students are responsible for ensuring they have a reliable mobile device at each lecture.*

- **Midterm**
 - Undocumented absences are not permitted for the midterm. If a student misses the midterm due uncontrollable or unforeseen circumstances, then the student must submit formal documentation and receive accommodation from the Dean's office to take the scheduled makeup.
 - Both the instructor and Dean's office should be notified within 48 hours of the missed assessment or accommodation may not be considered. See the policy and weblinks listed in the King's Policy statements at the end of this outline.
 - For students who pass at least one exam (midterm or final), the final exam weight may be up to 50% if their final exam is higher than the midterm. However, the final exam weight cannot be transferred to the midterm.

- **Group Project**
 - The electronic copy of your data report must be in Microsoft Word format.
 - Both the Excel dataset and the electronic copy of the report need to be uploaded to OWL Assignments before the deadline to be marked.
 - Final Reports are due at 11pm on Dec 5th, 2025 but will be accepted up to 11 pm on Dec. 8th, 2025 without penalty. On Dec 9th, students will receive a grade penalty of 25%, and a grade of 0 applies after Dec 9th. Students should submit whatever they have before the late deadline.
 - Instructors reserve the right to seek **additional clarification** about any submitted work (**e.g. explain a solution and oral interview**) as part of any assessment.
 - The instructor reserves the right to reduce individual group member grades on group projects or remove a member from a group where it is evident that the member did not make adequate contributions. If you are in a group that is refusing to invite or incorporate your work, you need to let the instructor know as soon as possible so this dysfunction can be addressed.

1. Academic Accommodations, Consideration for Absences

Academic Accommodation (Accessibility)

Accessibility Services works to ensure that academic programs are accessible to all students, and supports students who may have a condition related to, but not limited to, vision, hearing, mobility, different ways of learning, mental health, chronic illnesses, chronic pain, autism spectrum disorder, ADD/ADHD, and temporary conditions (beyond short-term academic consideration). Academic Consideration for Student Absence

If a student is unable to meet a course requirement due to substantial but temporary extenuating circumstances (medical or compassionate), they should follow the procedures below.

In some cases, where instructors have built flexibility into their assessments, this flexibility will already address consideration needs.

Requests for academic consideration should be directed to the Academic Advising Office of your faculty/college of registration. Requests must be made as soon as possible and no later than 48 hours after the missed assessment.

Students are permitted one academic consideration request without supporting documentation per term per course.

Instructors may designate one assessment per half-course weight as requiring formal supporting documentation. Please refer to the course outline for each course.

Absences from Final Examinations

If you miss the Final Exam, contact the Academic Advising Office of your faculty/college of registration as soon as you are able to do so. They will assess your eligibility to write the Special Examination (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a “Multiple Exam Situation” (e.g., more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred. Religious Accommodation
