Course Objectives

This course analyzes the causes and consequences of international trade and investment. We will investigate why nations trade, what do they trade, and who gains from trade. We will then analyze the motives for countries to put trade barriers and study the effects of such policies on economic welfare. Topics covered will include the effects of trade on economic growth and distribution, foreign direct investment, international trade agreements and current trade policies.

Learning outcomes

By the end of this course, you will be able to:

- Understand the reasons why nations trade.
- Understand and analyze trade theories explained in class.
- Explain the process of importing and exporting.
- Understand the impact of trade policy and institutions.

Achieve Assignments:

Each chapter will have associated homework questions to improve your understanding of course material. These questions will be available via Achieve and repeatable but must be done by 11:55PM on the assigned due date. Your final grade will be determined by your best score on each assignment, and your lowest score will be dropped. Additional details and instructions will be posted on course website. There is **no academic consideration** for late or missed assignments outside of exceptional circumstances.

Exams:

Midterms will be held during regularly scheduled lecture times. A final exam will be held on the official date scheduled by the university. All exams might include multiple-choice and short-answer questions; the final exam is cumulative. Students that miss midterm 1 will require documentation that is approved by academic counselling to write the make-up. Students that miss midterm 2 will have the weight transferred to the cumulative final exam. There is no makeup midterm 2: if you cannot take midterm 2 at the scheduled time, your grade will be re-weighted towards the final exam, so the final exam will count for 60% of the grade. *If you are struggling, please meet with me EARLY in the semester for assistance and feedback.*

I expect that you will actively participate during class discussions. Please do not hesitate to ask questions in class and during my office hours. Remember: there are no bad questions!

You must adhere to the following rules:

1. Academic Accommodations, Consideration for Absences

Academic Accommodation (Accessibility)

Accessibility Services works to ensure that academic programs are accessible to all students, and supports students who may have a condition related to, but not limited to, vision, hearing, mobility, different ways of learning, mental health, chronic illnesses, chronic pain, autism spectrum disorder, ADD/ADHD, and temporary conditions (beyond short-term academic consideration). Academic Consideration for Student Absence

If a student is unable to meet a course requirement due to substantial but temporary extenuating circumstances (medical or compassionate), they should follow the procedures below.

Students are permitted one academic consideration request without supporting documentation per term per course.

Instructors may designate one assessment per half-course weight as requiring formal supporting documentation. Please refer to the course outline for each course.

Absences from Final Examinations

If you miss the Final Exam, contact the Academic Advising Office of your faculty/college of registration as soon as you are able to do so. They will assess your eligibility to write the Special Examination (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a “Multiple Exam Situation” (e.g., more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred. 5. Copyright of Course Material
