The course will examine the social and economic impact of epidemic disease in North America by discussing outbreaks of yellow fever, cholera, diphtheria, smallpox, Spanish influenza, polio and encephalitis. Also analyzed will be the evolution of public health services, medical theories and governmental regulations in response to such epidemics.

Epidemics in North America

About: This course explores manifestations of epidemic disease in North American history. Beginning with pre-contact Indigenous groups and concluding with the Covid-19 pandemic, course lectures trace the myriad cultural, political, economic, and environmental impacts of infectious illnesses. Far beyond mere harbingers of doom (although they did function in that capacity as well!), epidemics shaped and were shaped by the historical contexts in which they occurred, from the Revolutionary War to migration panics in late 1800s to the suburban imperatives of post-WW2 societies. Topics include smallpox, cholera, syphilis, and Covid-19.

There are no required textbook purchases for this course. However, students are expected to read assigned articles, which are available on the OWL course website. You will be tested on these readings.

Note: All tests will involve written responses. Potential formats include: short answer, reading responses, identification questions, essay questions. All materials from the course (lecture, videos, tutorial readings) are relevant to tests. The final exam will be held during the official exam period, as provided by Enrolment Services.

Midterm – 50%

The midterm will be made available at 9:00am on 10 February, and must be uploaded to Brightspace *in PDF format* by 9:00pm on 10 February. Failure to follow instructions will result in either a partial or full points deduction (see Assignments tab for full instructions).

The midterm will consist of short answer and essay-style questions and will cover all course materials up to that point, including assigned readings, lectures, and online resources. The purpose of the midterm is to assess your understanding of key concepts, themes, and arguments introduced in the course, as well as your ability to critically analyze and synthesize information across different sources.

You can expect a combination of short answer and essay-style questions, and you must

- Demonstrate knowledge of key texts, ideas, and themes:
- Draw on lecture content, reading & supplementary course materials

- Make clear, well-organized arguments supported by evidence from the course

The exam will take place online and be asynchronous -- it must be completed individually and without outside sources unless otherwise specified.

Final Exam – 50%

The final exam will be online, asynchronous, with a specific date in April provided by the Registrar. Failure to follow instructions will result in either a partial or full points deduction (see Assignments tab for full instructions).

The final exam will follow a format similar to the midterm, consisting of short answer and essay-style questions, but it will cover the entire course — including all assigned readings, lectures, and supplementary material from the beginning of the term to the end. The final is designed to evaluate your ability to recall and explain key concepts, themes, and arguments from across the course, analyze ideas from multiple sources, and make-clear, well-supported arguments that reflect critical engagement with the material.

Like the midterm, the final will be online, asynchronous, and completed individually without external sources unless otherwise specified.

Academic Consideration for Student Absence

Students are permitted one academic consideration request without supporting documentation per term per course.

If you miss the Final Exam, contact the Academic Advising Office of your faculty/college of registration as soon as you are able to do so. They will assess your eligibility to write the Special Examination (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a "Multiple Exam Situation" (e.g., more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum
