COURSE TOPICS:

Matrix algebra including vectors and matrices, linear equations, determinants.

LEARNING OUTCOMES: students will

- Be able to manipulate vector and matrix expressions to accomplish required goals.
- Explore vectors, systems of linear equations and matrices.
- Understand how to determine the nature of solutions for systems of linear equations.
- Be able to calculate quantities from matrices including determinants and inverses.
- Learn how to express and manipulate equations of lines, planes, and hyperplanes.
- Solve application problems using different methods for solving systems of equations.

- **Final exam:**
 - If you miss the final exam with academic consideration, a makeup exam will be scheduled for you. Without academic consideration, the missed exam grade is 0.

1. Academic Accommodations, Consideration for Absences

Academic Accommodation (Accessibility)

Academic Consideration for Student Absence

Absences from Final Examinations

If you miss the Final Exam, contact the Academic Advising Office of your faculty/college of registration as soon as you are able to do so. They will assess your eligibility to write the Special Examination (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a “Multiple Exam Situation” (e.g., more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred.
