COURSE DESCRIPTION

An introduction to the role of marketing in the organization including information systems, corporate strategy, opportunities assessment, product differentiation, pricing strategies, distribution, communication and advertising.

COURSE OBJECTIVES

The goal of MOS 3320 is to provide you with a broad overview of the principles of marketing management and an understanding of how marketing strategy contributes to firm success. Topics we will cover in class broadly encompass market research and analysis, sales management and forecasting, advertising and promotion, product and pricing strategies, channel management and distribution, digital and new media marketing, and the marketing planning process. Marketing and sales play an important role within the larger firm context, and irrespective of

whether you hope to work in marketing or another unrelated function within the firm it is vital that you possess an understanding of the essentials.

MOS 3320 satisfies a course requirement for the Society of Management Accountants of Ontario.

Antirequisite: MOS 2320 A/B

Prerequisite: Business 2257 or MOS2227 and 2228 and enrolment in the four-year BMOS program. Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites. You also are responsible for ensuring that this course is not an anti-requisite to another course you already have taken.

COURSE LEARNING OUTCOMES

By the end of the semester, students will:

- ✓ Understand what marketing is as a business function, and how it can be used to drive revenue growth via appropriate marketing strategies
- ✓ Apply marketing principles to analyze typical marketing problems and business cases, and identify challenges and opportunities for firms within the marketing context
- ✓ Strengthen critical thinking and analytical skills (quantitative and qualitative) by using course concepts to analyze marketing cases and recommend a course of action with sound justification
- ✓ Improve written and oral communication skills via a series of active learning exercises, including group reports and presentations

REQUIRED COURSE MATERIALS & OWL SITE

MOS 3320 will require consistent access to high-speed internet, and a laptop that has a microphone, camera, and access to MS Excel. All Western students have free access to excel via their student tuition; if you need help accessing this please let me know.

Finally, you will be required to sign up for a free training tutorial via HubSpot, a third-party provider of marketing training and resources.

OWL: I will use OWL as the primary course website, and post grades, announcements, materials and so forth on OWL. I will also post the latest version of the syllabus, should it change. It is your responsibility to ensure that you have the most up-to-date version of the syllabus and all other information necessary for the course by visiting OWL on a regular basis.

TEACHING METHODOLOGY AND EXPECTATIONS

My class is interactive, and all classes have an in-class activity with participation marks. I use cases, newspaper articles, and short videos to reinforce key concepts, and expect you to integrate elements across the various classes. I expect students to come to class daily and actively participate in discussions and activities. Come to class prepared to participate, having completed all pre-work.

METHODS OF EVALUATION

Class Projects (3 x 10%): At the end of each week students will complete a recap/summary assignment, meant to demonstrate your ability to integrate and apply the concepts learned. Each assignment will be due 24-hours after the last class of the week, but there will be a 24-hour grace period following that before which a late penalty will be applied. Assignment details can be found on OWL.

- Assignment #1 due Friday, June 5th at noon – late penalty of 20%/day applied on assignments received after June 6th at noon
- Assignment #2 due Friday, June 12th at noon – late penalty of 20%/day applied on assignments received after June 13th at noon
- Assignment #3 due Friday, June 19th at noon – late penalty of 20%/day applied on assignments received after June 20th at noon

Participation (20%): Each class will have dedicated time set aside to discuss either assigned readings, cases, and/or engage in other active learning activities such as sales role plays, debates, and exercises. Your participation mark will be based then not only on attendance but also the degree to which you come to class prepared, actively participate in class activities, and add value to group discussion. Students will not only be rewarded for active participation, but may be penalized for distracting behavior (talking during presentations, texting, etc.) There may also be some hand-in homework assignments as part of this 20% contribution mark. You can elect to miss one class without penalty, or drop your lowest participation mark.

Final exam (50%): This course will administer its final exam **in-person**. By way of registering in this course, students are automatically registered to write their final exam in London. Students may opt-in to write at one of King's authorized testing centre locations in Toronto, Vancouver or Beijing. For those opting to write in Beijing, Toronto or Vancouver, you must register to write at those locations.

Instructions with a link to the registration form are available on the front page of the course Brightspace site.

The final exam will cover your understanding of the concepts covered in the course, via the application to various marketing scenarios. The exam includes a range of mini-cases and short answer questions. The exam is “open book”, in that students can bring printed (paper-based only) notes with them in writing the exam.

Note: All components of the course must be completed and submitted to complete the course

1. Academic Accommodations, Consideration for Absences

Academic Accommodation (Accessibility)
