Course Objectives

This course will provide students with theory and concepts of financial accounting particularly emphasis on financial statements, current and long-term liabilities and shareholders' equity, employee benefits, and statement of cash flows.

Learning Outcomes

Upon successful completion of this course students will be able to:

1. Assess the accounting issues associated with the liabilities and shareholders' equity side of the Statement of Financial Position in order to determine the most appropriate approach to the measurement, presentation and disclosure issues.
2. Apply present value concepts to solve accounting problems.
3. Properly account for current and non-current liabilities, income taxes, pensions and other post-employment benefits, leases, various complex financial instruments, earnings per share, accounting errors, and changes in accounting policies and estimates.
4. Prepare the Statement of Shareholders' Equity and the Cash Flow Statement and communicate the results using the appropriate format.

This course is also designed to expose students to the CPA Enabling Competencies:

1. Acting ethically and demonstrating professional values
2. Leading
3. Collaborating
4. Managing self
5. Adding value
6. Solving problems and making decisions
7. Communicating

Teaching Methodology and Expectations

Class sessions will include a blend of lecture, class discussions, and problem solving. It is expected that all readings will be completed, and all assigned problems will be attempted prior to class, and that each student will come to class prepared to discuss the material. Class participation is an integral component of each session. Many accounting concepts will be taught through the problems that are discussed. You will be required to work through some problems in small groups during class time.

The workload for this course is very heavy; students should schedule their time accordingly. For many, this course requires considerable practice outside of class. For this reason, self-study problems are provided. These problems are not optional; they are considered a core part of the course and material from them will be included in examinations. Please work through these problems on your own, and then to compare your solutions to posted solutions. Be sure to ask if you have any questions about the self-study items, or if you would like further clarification about them.

Students are required to complete all components. Students must attend and engage in at least 75% of classes, submit the accounting tasks assignments, and pass the final exam to pass this course. There are no exceptions to this. Extra assignments to improve grades will NOT be permitted and reweighting of grades will not occur. Grades will not be adjusted on the basis of need. It is important to monitor your performance in the course and keep up to date. You are responsible for your grades in this course.

It is expected that all students will perform and submit their own independent work. Cheating and plagiarism will not be tolerated. Maximum academic penalties will be applied, including a zero for the assessment or for the course, and possible expulsion from King's University College.

Please note that this is a course approved by the Chartered Professional Accountants of Ontario (CPA Ontario) to meet the prerequisite course requirement for admission into the CPA Professional Education Program (PEP).

Evaluation for Missed Assessments

Midterm Exam: This test is considered to be central to the learning objectives for this course. Accordingly, students seeking academic consideration will be required to provide formal supporting documentation to academic counselling. Students that are granted academic consideration for this test will be provided with an opportunity to write a make-up test. The date and time for the make-up test will be determined after the regularly scheduled test has been written.

Final Exam: According to Senate policy, all students seeking academic consideration for the final exam will be required to provide formal supporting documentation to academic counselling. Students that are granted academic consideration for this text will be provided with an opportunity to write a make-up test. The date and time for the make-up test will be determined by the Registrar's office.

Essential Learning Requirements

Even when Academic Considerations are granted for missed coursework, the following are deemed essential to earn a passing grade:

- Students must attend and participate in at least 75% of classes to write the final exam.
- Students must independently complete assignments; and
- Students must pass the final exam to pass the course.

Students who do not meet these requirements will receive a final course grade of 45%.

Students who miss too many assessments due to illness and have approval from Academic Counselling to receive credit will be given an opportunity to complete the missed assessments with the next offering of the course. Students in this situation will receive a grade of Incomplete (INC) and their maximum course load may be reduced during the term in which they complete their course requirements.

Weekly Participation (10%)

It is expected that students will attend all classes, arrive on time and act in a professional manner that is respectful toward the instructor and other students. Class participation and engagement is an integral part of the learning experience in this course. Therefore, it is expected that every student will be prepared for each class and will be a willing participant in discussions.

Participation will be evaluated on the eight (8) best classes. The lowest two (2) classes will be dropped. As a result, academic consideration requests will be denied for the first two (2) missed classes.

Participation marks are not "easy" marks. They are awarded for making class better by contributing to discussions.

The following scale is used to grade participation:

0 - (0%) - did not attend, and it is not an excused absence.

- 0 - (0%) - attended, but spent the class period working on other things. Did not participate in class activities. Did not demonstrate professionalism.
- 1 - (25%) - attended, participated in class activities, but did not ask or answer any questions.
- 2 - (50%) - attended, participated in class activities, answered questions related to items being discussed.
- 3 - (75%) - attended, participated in all class activities, answered questions throughout the class session. Preparation for class is apparent.
- 4 - (100%) - attended, participated in all class activities, answered questions that required interpretation or evaluation of accounting concepts. Preparation for class is apparent. Went beyond just answering homework questions. Explained difficult concepts. Added considerable value to the class.

Please note that attendance does not equal participation. Active participation improves critical and higher-level thinking skills. Participation can also help students learn from each other, increasing comprehension through cooperation and finding gaps in their reasoning.

It is also a great way of improving job preparation and developing your leadership skills. In many professional contexts (i.e., your career), you will need to be able to speak up in a group—either in a speech, presentation, or interview—that must be done verbally. You will offer information, ask questions, or argue for a different solution. It is one of those skills best developed with practice.

Examinations

Exams may have a combination of multiple choice, long-answer, and written-response questions.

For all examinations you may bring writing utensils and a non-programmable calculator into the examination room. You may not use a phone as a calculator. No other materials will be permitted at your desk during the examination. This includes dictionaries, cell phones, iPods, etc. All electronic devices (includes cell phones) must be turned off and put away in your bag. They may not be on your person. Anyone found with an electronic device on their person will receive a grade of zero on the exam.

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating. In addition, assignments may be subject to plagiarism detection software.

How to do well in this course: PRACTICE, PRACTICE, PRACTICE!

To perform well in this course, you must spend considerable time reading the textbook and attempting assigned problems. To maximize your learning, you should make an honest attempt at the question before peeking at the solution. Simply reading a question and then turning to the solution right away is next to useless. You will find that there is likely a direct correlation between the number of problems you prepare on your own and your course grade.

The following study approach is recommended for each chapter:

1. Read the chapter material in the textbook. Pay careful attention to examples.
2. Attempt the questions that have solutions.
3. Re-do the any questions that were incorrect. Attempt these on your own to see if you can arrive at the same solution as was posted.

4. Use the textbook as a reference source for topics you are having difficulty with.
5. Make quality reference notes. Many studies show that longhand note-taking trumps laptop note-taking.
6. Complete the additional assigned problems that are listed in the Weekly Course Schedule.

This is not a course to register in if you are seeking an easy credit. For many students, this course is a difficult one. Part of this difficulty stems from a challenging subject matter, but the biggest difficulty comes from failing to devote enough effort to working with the material. Accounting requires that you spend considerable time practicing questions --over and over and over. You are unlikely to learn by merely watching someone else "do accounting". It is absolutely essential that you keep up with the assigned readings and end-of-chapter problems.
