Calendar Description:

This course investigates non-European ways of thinking "philosophically." Students will study African oral traditions, Central-Asian, Chinese, Japanese, and Indigenous traditions by looking at their approach to fundamental questions: what is the human being? What is nature and what is our relation to it? What is knowledge and what is happiness?

The course examines and compares a wide range of written and oral traditions of philosophical thought. It attempts to answer the following questions: What are the thought and belief systems of philosophies from around the world, including African thought, Islam, Judaism, Indian and Chinese philosophy, North American Indigenous philosophies, etc.? How is ‘wisdom’ understood in these systems? Is it insight, or reflection? What can we learn by comparing various systems of thought with one another? What can Western philosophy learn from engaging other forms of thought?

Learning Outcomes

The course intends to make students familiar with the history, structure, and worldviews of a huge range of non-European cultures. Through discussions and reading of selected texts the course will increase critical and investigative skills and will bolster creativity and the production of original ideas. A comparative anthropological and multi-perspectival approach will be taken in order to provide an active learning experience and a deep understanding of the structural similarities based on which a fruitful dialogue and mutual respect can be generated.

Readings and **videos** will be posted on the Owl system, students do not need to purchase reading material. Thus, this course has no additional fee for students

Evaluation: midterm test (Feb 9) **30%**, writing project **20%** (the 1500 word writing projects should be handed in two weeks before the end of classes), class presence and participation **10%**, final exam **40%**.

1. Academic Accommodations, Consideration for Absences

Academic Accommodation (Accessibility)

Academic Consideration for Student Absence

If a student is unable to meet a course requirement due to substantial but temporary extenuating circumstances (medical or compassionate), they should follow the procedures below.

Students are permitted one academic consideration request without supporting documentation per term per course.

Absences from Final Examinations

If you miss the Final Exam, contact the Academic Advising Office of your faculty/college of registration as soon as you are able to do so. They will assess your eligibility to write the Special Examination (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a “Multiple Exam Situation” (e.g., more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred. Religious Accommodation

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

5. Copyright of Course Material

Lectures and course materials, including PowerPoint presentations, tests, outlines, and similar materials are protected by copyright. Faculty members are the exclusive owner of copyright in those materials they create. Students may take notes and make copies for their own use. Students may not allow others to reproduce or distribute lecture notes and course materials publicly (whether or not a fee is charged) without the express written consent of a faculty member. Similarly, students own copyright in their own original papers and exam essays. If a faculty member wishes to post a student's answers or papers on the course website, they should ask for the student's written permission.

Any student who, in the opinion of the instructor, is absent too frequently from class or laboratory periods in any course, will be reported to the Dean of the Faculty offering the course, after due warning has been given.
