4060. Plato's Philebus

We will read Plato's *Philebus*, with the aid of which we will explore the different types of dialogue Plato conducts, how essential dialogue is for philosophy (and for our lives), and in what specific ways, if Plato's dialogues are not just literature. We will also examine various elements important for a theory and experience of pleasure, as well as its role in human life—such as the varieties of pleasure, the question of whether pleasure can be unified, and whether (some) pleasures are forms of thought. With some digressions to the *Protagoras* and Aristippus the Socratic, we will also consider different models of rationality when considering overall well-being, including the maximizing model, which is often taken to be the default in contemporary discussions, and an alternative, the eudaimonic model of well-being.

I. General Information:

COURSE NATURE: Philosophy 4060G is a one-semester course.

MODE OF INSTRUCTION: In-person

OFFICE HOURS: My regular office hours will be after class. Stay in class please and we can discuss your questions.

READINGS: The students are responsible for reading and bringing the required Platonic dialogue in class. *They must buy the specific edition:* Plato. *Philebus*. Hackett Edition. ISBN-10: 0872201708/ amazon price is 20.23 CAD. Any additional texts will be scanned and shared with students at no cost.

II. Requirements:

- Midterm Exam, **March 12: 30%**
- Participation in class discussion **15%**
- **Presentation: 20%**. It is the students' responsibility to register for this assignment and present during a session.
- A Research Paper: i) abstract due **on March 12 (10%)** and (ii) the paper written **on March 19** in class: **25%**

The research paper will be worthy of 35% of the final grade (10% the abstract and 25% the paper in class March 19). The students are free to choose one debate to develop their paper or a topic of relevance to the topics we cover in class. The abstract is due on March 12: electronically.

Abstracts (300 words) must be submitted to the assignment box of Dr. Mouroutsou's OWL site **by March 12.**

In the abstract, you must use **at least two bibliographical references (this means secondary literature referred to in the essay) and at least one primary text.**

In the paper you write in class, it will NOT suffice that you quote a phrase from secondary literature. Instead, you must show active engagement with the work you refer to.

You can use Internet search engines like **jstor** to find relevant references. Moreover, the **Stanford Encyclopedia of Philosophy** is an excellent source. But in the paper, you must quote secondary literature (books or articles) and not internet sources.

I cannot accept undocumented absences/self-reports for the abstract/essay in class.

We will talk about essay-writing in class. (see schedule).

B. Mid-term Exam:

There will be a mid-term exam for the class **on March 12**, which will be worth of **30%** of the grade.

III. Course Content and Objectives

The objectives of this class are the following:

- to make the students familiar with the discussions of pleasure in Plato's *Philebus* (Aristotle will offer a different model/ our basic text is the *Philebus*), and show them how relevant these discussions are throughout the history of philosophy.
- To invite the students to think about the relation between pleasure and pain.
- To make the students familiar with the different kinds of philosophical hedonism (Aristippan hedonism and maximizing hedonism)
- To make the students pursue the critical dialogue and appreciate the power of genuine dialogue by reading Plato's work and participating in our discussions.

IV. Schedule WT (subject to small changes, if they are considered to be necessary):

Jan. 8: Intro (Syllabus; requirements; dialogue and types of dialogue in Plato)

Jan. 15: *Philebus* beginning till 20c. The dialectic of one and many

Jan. 22: *Philebus* 20c-23b. Lives in Contest (pleasure, intelligence and mixture of both)

Jan 29: Philebus 23b-32c: the fourfold ontology and the mechanism of restoration

Feb. 5: read until 52c (we will not focus on all passages in the same way). The relationship to pain (in the concept of pleasure) will be a basic focus. Different kinds of false pleasures.

Feb. 12: 53c-55c (dialogue with whom?) and until the end of the dialogue

1. Academic Accommodations, Consideration for Absences
