Course Description and Learning Outcomes

A study of the political, economic, and social issues related to development and underdevelopment, including development strategies, global institutions, foreign aid, state building and democratization. The focus will be on Africa, Asia and Latin America, supplemented by attention to specific national and regional case studies.

By the end of the course, students will be able to:

- Evaluate theoretical perspectives on development and apply this learning using examples from contemporary events;
- Analyze and debate the merits of approaches to development in both class discussion and writing;
- Develop an understanding of how concepts such as power, justice and identity contribute to our understanding of human development;
- Create high-quality research that draws on a variety of scholarly sources and demonstrates a variety of communication skills to aid in further university study and career goals.

Mode of Instruction and Expectations of Students

This class will take place in-person, during the scheduled class time. Class may take place on Zoom if necessary (for example, the instructor is ill). The first two hours of class will consist of a mix of lecture, video clips, class discussion, group discussion and other participation activities. Slides and participation materials will be available via the class website. Each week, students will:

- Read a reading before coming to class;
- Download the weekly materials from our class website before coming to class;
- Listen to a lecture and take notes to add class material to the lecture slides;
- Take part in the participation activities, and;
- Work on class assignments outside of class.

The third hour of class is scheduled as a tutorial, which will consist of a discussion or other participation activity about the week's assigned reading.

Method of Evaluation

Component	Weight	Date/Deadline	Description
Article summary	5%	Sept. 29	Students will write a 250-word summary of a scholarly journal article about a development problem in a country of their choosing. The goal is to practice understanding scholarly research.
Policy brief	25%	Oct. 27	Students will create a 1,250-word policy brief that recommends solutions to the problem in the country chosen to create the article summary assignment. The goal is to develop research skills and problem solving.
Critical analysis	25%	Nov. 24	Students will write a 1,250-word analysis that critiques an international development non-governmental organization that works on the problem in the country chosen to create the article summary assignment. The goal is to develop a well-articulated opinion supported by high-quality research.
Final exam	30%	Dec. exam period	Students will complete a final exam during the December exam period. The goal is to show mastery of course material.
Class participation	15%	Ongoing	Participation will include attendance and taking part in class. The goal is to create a lively classroom environment. There will be opportunities for bonus participation marks, too.

Assignment Submission and Academic Consideration

Assignments are due by 9:30 am on the due date via the class website. There is a three-day grace period to hand in your assignment without late marks, no questions asked. After that, the late penalty for the assignments is 3% per day. Assignments will no longer be accepted one week after the due date. To receive an accommodation for all assignments, documentation from an academic advisor is required.
