Course Description and Learning Outcomes

This course introduces students to the study of global politics. Drawing on a range of perspectives, the course examines the most significant issues in global affairs such as war, peace, terrorism, security, diplomacy, nationalism, global justice, global environment, globalization, global governance, poverty, development, human rights, gender and inequality.

By the end of the course, students will be able to:

- Critically understand different ways of thinking about global issues and apply this learning using examples from contemporary affairs;
- Analyze various political concepts by evaluating their relative merits in both debate and writing;
- Evaluate the merits of solutions to global issues and demonstrate a thorough understanding in class activities;
- Demonstrate a critical awareness of different ways of participating in world affairs to develop active citizenship;
- Create high-quality research that draws on scholarly sources and demonstrates multiple communication skills to aid in further university study and career goals.

Teaching Methodology and Expectations of Students

This class and tutorial will take place in-person, during the scheduled time. Each week, students will:

- Download the weekly materials from our class website;
- Listen to a lecture and take notes to add class material to lecture slides;
- Take part in in-class participation activities;
- Read an assigned reading before attending tutorial;
- Attend a tutorial for small-group discussion with a tutorial leader, and;
- Work on class assignments.

Class or tutorial may take place on Zoom if necessary (for example, due to bad weather).

Evaluation Breakdown

Component	Weight	Date/ Deadline	Description
Op Ed #1	25%	February 2	Students will write a 750-word opinion editorial expressing their opinion on an important international news story of their choosing, drawing on a variety of sources. The goal of the assignment is to practice expressing a well-articulated personal opinion.
Op Ed #2	30%	March 9	Students will write a second 750-word opinion editorial expressing their opinion on a different important international news story of their choosing, drawing on a variety of sources. The goal of the assignment is to practice improving work
Exam	30%	April exam period	Students will complete a final exam during the April exam period. It will consist of written questions. The goal is to show mastery of course material.
Tutorial Participation	15%	Ongoing	Students will be evaluated on the quality and quantity of their participation during tutorial. The goal is to create a lively classroom environment. Students can miss one tutorial without losing marks.

Assignment Submission and Academic Consideration

Assignments are due by 2:30 pm on the due date via the class website. There is a three-day grace period to hand in your assignment without late marks, no questions asked. After that, the late penalty for the assignments is 3% per day. Assignments will no longer be accepted one week after the due date. 1. Academic Accommodations, Consideration for Absences

Academic Accommodation (Accessibility)

Academic Consideration for Student Absence

If a student is unable to meet a course requirement due to substantial but temporary extenuating circumstances (medical or compassionate), they should follow the procedures below.

In some cases, where instructors have built flexibility into their assessments, this flexibility will already address consideration needs.

Requests for academic consideration should be directed to the Academic Advising Office of your faculty/college of registration. Requests must be made as soon as possible and no later than 48 hours after the missed assessment.

Friday Make-Up Exams may only be written with the instructor's consent.

Absences from Final Examinations

If you miss the Final Exam, contact the Academic Advising Office of your faculty/college of registration as soon as you are able to do so. They will assess your eligibility to write the Special Examination (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a “Multiple Exam Situation” (e.g., more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred. See the Academic Calendar for details (under Special Examinations).

Religious Accommodation

5. Copyright of Course Material
