Western Religions: Judaism and Islam

Course Objectives

This course provides a systematic introduction to the history, faith and tradition of Islam and Judaism. We will concentrate on the following topics: 1. What is the essence of Jewish and Islamic faith? 2. What is Islamic and Jewish theology? 3. What are the main stages of Jewish and Islamic thought and history? 4. Jewish and Islamic political models? 5. Islamic (*Sufism*) and Jewish mysticism (*Kabbalah*)

Learning Outcomes

The course intends to make students familiar with the history, structure, Scriptures, cultures and traditions of Islam and Judaism. Through discussions and reading of selected texts it will increase critical and investigative skills and will bolster creativity and the production of original ideas. A comparative and multi-perspectival approach will be taken in order to provide an active learning experience and a deep understanding of the structural similarities based on which a fruitful dialogue and mutual respect can be generated.

Academic Consideration for Student Absence

If a student is unable to meet a course requirement due to substantial but temporary extenuating circumstances (medical or compassionate), they should follow the procedures below.

Students are permitted one academic consideration request without supporting documentation per term per course.

Absences from Final Examinations

If you miss the Final Exam, contact the Academic Advising Office of your faculty/college of registration as soon as you are able to do so. They will assess your eligibility to write the Special Examination (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a “Multiple Exam Situation” (e.g., more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred. Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

5. Copyright of Course Material
