Mode of instruction: In-person

Course description:

This course investigates the relationship between globalization, justice and forced migration, emphasizing experiences of the forcibly displaced around the world. The approach is thematic, engaging a variety of theories and methods to explore the causes and consequences of forced migration and possibilities for change. We consider the ongoing challenges and unjust practices faced by migrants today and explore more just and humane alternatives to the current structure. In so doing, we will also explore the colonial and imperial foundations of the current violent and exclusionary practices towards migrants and asylum seekers.

Course learning outcomes:

- Engage complex literature on immigration, asylum, and refugees.
- Become familiar with the ongoing social, political, economic, and cultural challenges and injustices in contemporary immigration.
- Gain an understanding of the colonial and imperial roots of contemporary asylum and immigration policies and practices.
- Consider and explore more humane and just alternatives to the current immigration and asylum strategies.
- Develop student presentation and argumentation skills in a range of formats (oral, written, video/podcast).

Course textbooks/materials:

- *Readings and other materials will be provided through Brightspace at no additional cost from an array of sources. Students will be required to complete a book review for this course. Most books are available through the library and/or online, but students are free to purchase them should they so choose.*

Participation

In class participation, your weekly journal, together with "jigsaws" accounts for a total of 25% of students' final grade. Marks will be awarded for raising questions and concerns pertinent to the readings, expressing cogent arguments, and general participation in the discussion that demonstrates some comprehension and critical engagement in the required material covered for that specific session. Simply talking to fill time and space will not result in positive marks. Before coming to class, students ought to have read, viewed, and/or listened to the appropriate material listed in the syllabus, and consider the following before attending the seminar, which should be addressed in a brief journal entry: what is the primary argument? What is particularly interesting and/ or relevant about the material? Is the argument persuasive? Attempt to critically evaluate the internal and external logic of the argument(s) presented; reflect on the broader implications for the themes in our course; and raise at least two interesting and provocative discussion questions. The journal expectation refers to the fact that students will come to class with prepared notes and/or questions for discussion related to the materials covered that day.

Jigsaws 10% [21 January; 25 February; 11 March]

A jigsaw exercise is a collaborative learning strategy where students become "experts" on one part of a topic and then share their knowledge with peers. A handout is provided for each Jigsaw exercise, available in this tab. Please come to class on the Jigsaw Day, prepared to present your assigned topic to your peers. You will be placed in groups with students who have become experts on **different topics**, and you will present and share your expertise respectively with the members of your group.

Class Facilitation [Sign-Up for Date at First Session – 10% Total]

You are required, individually or in pairs, to present readings for one class. We will sign up for this on the first day of class, so the schedule is clear. This presentation should not summarize the readings, but critically engage the arguments presented and provide provocative and engaging questions and material for class discussion, going beyond the readings to provide additional insight. Because we are online, things will be somewhat different than normal. While you will still act as the discussion leader for the class you have signed up for, what is more essential for this assignment is that you are required to upload either a one-page study guide for the class not less than 24 hours prior to class, or a brief video or podcast that accomplishes the same. The guide, whether in writing or audio/video, should be enticing and engaging, exciting students about the class ahead, and raising some key points and questions that you intend to address.

What was the core theme or themes, and concept(s) raised in the readings? How do the readings reflect on migration, borders, and borderlands? How do these readings relate to the subject and themes of the course? To what extent have the arguments presented advanced your understanding of migration, borders, and borderlands? Explain.

BOOK REVIEW ESSAY [4 March – 20%]

A Critical Book Review Handout will be provided on OWL and discussed. This is a mandatory portion of the course and will be based on a book of your choosing from an approved list. This assignment should not exceed 1500 words and adhere to accepted academic citation styles. Further details and information will be included in the handout, and various style guides for MLA, APA and Chicago Style are available online through the library portal.

Although this essay is based primarily on a single text, students are expected to raise course material in so far as it is relevant to the arguments and discussions presented. Students are also strongly encouraged to consult *The New York Review of Books*, *The London Review of Books*, and/or *The Sunday New York Times Book Review*, for samples of well written, engaging book review essays, of the sort expected for this assignment. DUE 4 March. This assignment should not exceed 1500 words and is worth 20% of your final grade.

In-Class Oral Mid-Term [11 February– 15% Total]

Students will sit a one-on-one oral test with the professor on the course materials, lectures, discussions, readings, and concepts. A series of possible questions will be provided to students one week in advance to enable preparation. Students will be provided with a randomly selected timeslot during the class session on 11 February during which time an approx. 10 min oral examination will take place. Further details will be provided in class.

Research Proposal Paper (2500 words -April 8) 30%

This is a fulsome, well developed, research proposal. Students are not expected to conduct the research, but provide a framework, forward a developed thesis or research question, raise appropriate methodologies, provide a brief literature review, and an outline of the research paper. Further information will be provided in class. This is due 4 April and should not exceed 2500 words.

You must compose text, choose words, construct logic flow, structure sentences and paragraphs to organize, synthesize, interpret information with your own mind. When you borrow language or ideas from another person or from a machine this must be acknowledged with quotation marks and/or citations.

1. Academic Accommodations, Consideration for Absences

Academic Accommodation (Accessibility)

You may also be eligible to write the Special Exam if you are in a “Multiple Exam Situation” (e.g., more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred.
