Course Description

This course focuses on criminality and criminalization with specific attention to the operation of these processes across international borders. The course will attend to domestic crimes that have cross-border elements (e.g. tax evasion; child sexual abuse); transnational crimes (crimes across borders that impact the interests of multiple nation states); and international crimes (crimes that produce harm against humanity) as well as the judicial systems that respond to these crimes. Criminalization will be situated in relevant contexts and situated within regimes of international and intranational power.

Course Learning Outcomes:

Sociology

- Apply sociological concepts and vocabulary to transnational crimes
- Engage a range of sociological lenses to consider the same topic from different perspectives
- Articulate multiple understandings of a single issue/event

Academic Skills

- Apply disciplinary knowledge across a range of cases and problems
- Consider the impacts of contested meanings at local, national, regional, and global scales
- Identify the linkages between individual lived experiences and transnational processes
- Begin to engage with peer-reviewed scholarship

Students' Responsibilities

- Ask questions if you don't know; ask for help if you need help
- Read/watch/listen to and reflect on the assigned material before each class so that you are ready to work within the classroom to engage more deeply with the material
- Participate with curiosity in group discussions and group assignments
- Take seriously the arguments of other people with whom you disagree
- Arrange to get information from other students if you miss class
- Communicate respectfully with other students and your professor

Professor's Responsibilities

- Support students who are developing new academic (and possibly adulting) skills
- Curate readings, podcasts, films, etc. related to course objectives
- Provide constructive feedback on assignments so that students can improve their work
- Be available outside of class times to discuss course material or other academic issues

Case Study – Working individually, in pairs or in a group of three, you will identify a transnational criminalized activity in a specific geographical location. Your case study will incorporate peer-reviewed literature and situate this crime within a sociological context (including and beyond the course content), attending specifically to the transnational elements of this activity. If completed as a group project, this assignment will include peer evaluation. More details will be available on OWL.

Final Exam – This fill-in-the-blank, short answer, and paragraph answer exam will assess your overall learning in the course. This exam will cover all course content (readings/lectures), as well as the case studies created by you and your peers.

Given that the in-class activities/engagement grade is calculated out of fewer classes/activities than will be held, there is no academic accommodation for this assessment. I do not offer additional assignments to make up missed coursework.

Appealing your Grade

You may appeal your overall grade or the grade of any specific assignment. To appeal a grade, you must first have an informal discussion with me, the professor. If you find my explanation of your grade unsatisfactory, the next step is to write a letter outlining the grade you believe you deserve for your work and providing evidence of the ways your work met the requirements for this grade. Please note that the onus is upon you to demonstrate that you deserve a better grade, not for me to defend the mark I assessed.

The following are not relevant grounds for appealing grades & will result in an **immediate dismissal** of your appeal:

- Previous grades in this course were higher
- Grades in other courses are higher
- A lot of effort was put into the assignment
- Other students/family/friends/etc. are of the opinion that you should have a higher grade
- You didn't understand the assignment
- You need a higher mark to maintain a certain average or to get into a certain program

You must begin the appeal process (i.e. schedule an informal meeting) within **2 weeks** of receiving your grade. No grade change will be considered without submitting a formal appeal to the professor. The formal appeal process may result in your grade going up or going down.

Academic Integrity

Generative AI is not permitted in this course, even for preliminary elements of writing, such as generating questions and drafting outlines. Students are responsible for ensuring that their essays and assignments are properly cited using parenthetical citations or quotation marks where appropriate.

Academic misconduct includes, but is not limited to:

- Presenting the work of others (including generative AI, friends, professional essay writers, and scholars) as your own
- Submitting the same work in two or more courses
- Failing to use appropriate referencing
- Not providing specific references for ideas or material that you encounter through the course instructor or classmates

Academic misconduct is not tolerated at King's University College and it makes me especially grumpy.

If I suspect academic conduct related to any of your assignments, you will be required to meet with me in-person before I will assign any grade. 1. Academic Accommodations, Consideration for Absences

Academic Accommodation (Accessibility)

Students are permitted one academic consideration request without supporting documentation per term per course.

Absences from Final Examinations

If you miss the Final Exam, contact the Academic Advising Office of your faculty/college of registration as soon as you are able to do so. They will assess your eligibility to write the Special Examination (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a “Multiple Exam Situation” (e.g., more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred. Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

5. Copyright of Course Material

Lectures and course materials, including PowerPoint presentations, tests, outlines, and similar materials are protected by copyright. Faculty members are the exclusive owner of copyright in those materials they create. Students may take notes and make copies for their own use. Students may not allow others to reproduce or distribute lecture notes and course materials publicly (whether or not a fee is charged) without the express written consent of a faculty member.
