This course explores the historical and political context in which Human Rights are recognized as a discourse in Canadian society. It examines the complexity of human rights and the contradictory forces which have led to successes and failures in protecting minorities in this country.

Course Overview

This course examines ethnic and racist prejudices and discrimination in Canada including attitudes towards immigrants from Asia and Europe, African Canadian, and Indigenous peoples. It will also explore the efforts of human rights advocates. Throughout the course, students will examine developments in racial equality and human rights, primarily since 1945. Weekly discussions based on assigned materials will offer students an opportunity to explore such questions as: What are "human rights" and how are they different from any other rights? Where do human rights come from? Why do they change over time, and by whom and by what means are changes made? How can we apply this knowledge to public policy and to outstanding human rights issues? Can the Canadian experience serve as a model for other societies? The focus for our study will be the formation and evolution of Canadian human rights, but with considerable attention paid to international events which have provided context for what was/is happening in Canada. This course is offered in-person only.

Course Objectives:

1. To provide students with a knowledgeable background on Canada's approach to human rights in the nineteenth and twentieth centuries via lectures, discussions, films, and guest speakers.
2. To assess critically academic debates within the context of the past through lectures and in-class debates.
3. To develop and enhance communication and critical reasoning skills through reading, analysis of sources, and seminar participation.
4. To offer students an opportunity to discuss and to critically analyze the development of human rights in the Canadian context in an open and collegial environment.

Learning Outcomes:

Upon successful completion of this course students will be able to:

1. Identify the key figures and issues and their influence on the development of human rights in Canada's past and present.

2. Outline the major eras and the defining relationships (international and domestic) that shaped the development of human rights and rights culture.
3. Assess rights claims and place them in their historical and issue-specific context.
4. Articulate reasoned arguments about various aspects of the study of human rights in Canada in both verbal and written forms.

I acknowledge that our campus at King's University College is situated on the traditional territories of the Anishinaabek, Haudenosaunee, Lenapeewak, and Chonnonton peoples, all of whom have longstanding relationships to the land of Southwestern Ontario and the City of London. The First Nations communities of our local area include Chippewas of the Thames First Nation, Oneida Nation of the Thames, and Munsee Delaware Nation. And in our region, there are eleven First Nations communities, as well as a growing indigenous urban population. King's University College values the significant historical and contemporary contributions of local and regional First Nations, and all of the Original Peoples of Turtle Island (also known as North America).

Course Structure

Generally, classes will start with a lecture, followed by a film or activity and finally a discussion period. Our weekly class meetings are intended to bolster work done on your own time (reading, writing and thinking). You are expected to attend the majority of classes and be prepared to discuss the assigned readings for each week. You should complete readings before class and attend with one talking point or question that responds in some way to the reading. You are expected to complete both of the two assignments to be permitted to write the final exam.

COURSE TEXTS

There are no required course texts to purchase. Course Readings are available on OWL and/or on reserve in the Cardinal Carter Library.

ASSIGNMENTS

Film Reflection Piece

You will write a 1500 word analysis of a film to be viewed in class on **Monday September 28**, the assigned materials, and the associated class discussion. Your analysis should include the following:

1. A brief, overall description of the film;
2. A discussion of the film, readings, and class discussion, which addresses certain questions (to be posted to OWL);
3. A conclusion that draws together your analysis of the film in a way that relates to more general issues, such as the use of film as an instructional tool and what you learned about human rights through it.

Further details are available on OWL. The assignment is due on **Tuesday October 6**.

Guest Speaker Reflection Piece

You will write a 1500 word analysis of any one (1) guest speaker's presentation, your own thoughts, and assigned readings. Your analysis should include the following:

1. A brief, overall description of the guest speaker's presentation;
2. A discussion of the presentation, assigned materials, and your own analysis which addresses certain questions (full description posted to OWL);

3. A conclusion that draws together your analysis of the entire event in a way that relates to more general issues, and what you learned about human rights through it. Further details are available on OWL. The assignment is due **within 9 days following the guest speaker's presentation.**

FINAL EXAMINATION

The final examination will be held during the regular December examination period. More detailed comments and advice will be offered on **Dec. 7, 2026.**

DISCUSSIONS

Discussions of course material form an integral part of HRS 2900F. Discussion attendance and participation are therefore expected at all of the scheduled meetings. The readings and articles chosen for each discussion supplement the lectures with additional information and, certainly, some different interpretations, and are designed to contribute to your own evolving understanding of the development of human rights. Use your voice in class to share your informed analysis of the issues. This is great training for life, when you may be called upon to speak up, and speak with conviction and accuracy!

Be prepared to make regular contributions to our discussions, as participation makes up a substantial part of your grade. **Attendance will be taken at each discussion session. Participation grades will be based on attendance, the consistency of your contributions, and the quality of your remarks.** More information on participation is in a Participation Guidelines document on OWL. *Like the lectures, assigned articles from these collections will be subject matter for tests and examinations.*

On the recommendation of the Department concerned, and with the permission of the Dean, the student will be debarred from taking the regular examination in the course.*

How to Prepare for Discussions

Here are some questions to keep in mind to help you prepare your notes and comments for discussions:

1. What did you think of the assigned materials? Why? Any surprises?
2. What are the main points of the assigned materials?
3. Do the assigned materials present different viewpoints? What are they?
What accounts for the differences in opinions?
4. What do you think are the goals of the creators? Why did they create what they did?
5. What are the strengths and weaknesses of the assigned materials?
6. Have the assigned materials challenged or added to your understanding of the topic?
Why and how?
7. What questions or issues do the assigned materials raise in your mind?

COURSE COMMUNICATIONS

Your communication with professors should mostly be in-person; email should be used largely for simple, yes/no sort of questions – or to make an appointment. Students who do not normally use a UWO email account should be aware that external messages may be delayed by UWO's Spamtrap. You are strongly advised to discuss course-related matters with your professor during their scheduled office hours. This is the best way to succeed in HRS 2900F. It is also much nicer to have a face-to-face conversation!

Inappropriate use of laptops and cell phones during lectures, seminars, labs, etc., creates a significant disruption. Please do not distract your fellow students in the class.

If you cannot meet a course requirement:

If you are unable to fulfill the course requirements you should refer to College regulations. I advise you to plan ahead to allow enough time to complete assignments in the event of minor illnesses or personal problems. 2. Academic Consideration for Student Absences

There are two ways to seek academic consideration:

(i) Academic consideration based on medical or compassionate grounds

(ii) Academic consideration through an undocumented absence

Students are permitted one academic consideration request without supporting documentation per term per half-course (0.5) weight.

- Note that instructors may designate one assessment per half-course weight as requiring supporting documentation. Please refer to the course outline to confirm this which assessment has been designated as requiring documentation for consideration (that is, exempt from undocumented absences).
- Undocumented absences can not be used as the basis for academic consideration for December or April exams.

If an instructor has built flexibility into their assessments (e.g., “complete 8 of 10 quizzes”), this flexibility will already address consideration needs and thus academic consideration may be denied.

c) Absences from Final Exams

If you miss the Final Exam, **contact your Academic Advising Office** as soon as you are able to do so. They will assess your eligibility to write the “Special Examination” (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a multiple exam situation (i.e., you are scheduled to write more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred.
