COURSE DESCRIPTION

This course provides students with an overview of intellectual and developmental disabilities (IDD), exploring past and present trends, policies, and practices. Students will gain a broad perspective of the ever-changing and developing environment that influences the lives of those labelled as IDD, considering new and evolving methods that promote disability rights.

COURSE LEARNING OUTCOMES

Upon completion of the course, students should be able to:

1. Critically analyze how intellectual and developmental disability has been historically constructed and governed in philosophy, law, and policy.
2. Evaluate the relationship between institutionalization, deinstitutionalization, and contemporary carceral systems and connect these frameworks to abolitionist and disability justice movement.
3. Interpret and apply ethical and philosophical arguments regarding personhood, agency, and moral worth in the context of intellectual disability.
4. Examine questions of sexuality, intimacy and self-determination for people with intellectual and developmental disabilities, assessing cultural, legal, and political discourses.
5. Synthesize contemporary approaches to supported decision-making, autonomy, and self-advocacy to propose inclusive practices that challenge biomedical models.

MODE OF INSTRUCTION

This is an in-person course with the following context:

1. Lecture

Students learn information concerning disability and labelling through an informal lecture structure. A modular concept assists students to learn material in sections and in an organized format. The open format encourages inquiry and discussions. Students should come prepared for class by completing any assigned readings or reflective assignments. PowerPoint format is used but students should take notes in order to gather adequate and relevant information for learning and testing purposes. Students are encouraged to express themselves in an open dialogue with the professor and their peers. Disability is a sensitive topic and students will be supported to feel comfortable in a respectful classroom environment.

2. Personal Narratives and Experience

The professor will share their direct clinical experiences of supporting persons with disability and give a reality base to theoretical information and concepts. Guest speakers will help demonstrate how principles learned in class apply in the real world

3. First-Person Emphasis

An inclusive atmosphere rather than an “us and them” perspective encourages the student to see that we all have, or will be touched or impacted by disability in the broadest sense.

4. Web-Based Activities

Web-based resources and evaluation will provide students with access to focused information to stimulate learning and reflection. Selected readings allow students to ponder alternative, and at times, critical perspectives about intellectual and developmental disability. Regular checking in to the course website will allow the student to be aware of upcoming class topics and activities and, to complete assignments.

COURSE TOPICS (to be confirmed)

- Why do we need to exercise care in using the term “developmental disability”?
- The personal, public, critical, and definitional meanings of developmental disability
- Changing conceptions of developmental disability, and labelling
- Factors causing or contributing to developmental disabilities
- Common syndromes and conditions associated with developmental disability
- The history - Normalization, deinstitutionalization, and the focus on community living
- Types of supports and services currently available in Ontario, formal and informal supports, person-centred approach, and inclusion
- Unique vulnerabilities of persons with developmental disabilities (sexual, mental health, rights)
- Current trends, issues, and challenges of developmental disabilities in Ontario
- How people with developmental disabilities and their families have challenged unfair and unequal treatment by asserting their human rights

ADDITIONAL NOTES

Respectful Classroom:

Disability is a topic that can be sensitive for some people for reasons that aren't always self-evident or visible. As such, it is expected that students will be open and respectful in our discussions to allow space for different, and potentially contrasting, points of view and stories of experiences. Students should feel welcome and free to present their thoughts and to ask questions. The Professor draws on his career in the field to present a variety of distinct and common case situations in order to give students a sense of how disability processes play out in real lives. This material is always adjusted to preserve people's confidentiality.

Computers and Electronic Messaging During Class Time:

1. Academic Accommodations (Accessibility)

2. Academic Consideration for Student Absences

Students must be approved to write a makeup exam or for an extension of the assignment deadline. If you need to miss an exam or the deadline for the assignment, please follow these instructions.

There are two ways to seek academic consideration:

(i) Academic consideration based on medical or compassionate grounds

If a student is unable to meet a course requirement due to substantial but temporary extenuating circumstances (medical or compassionate grounds), they should contact the Academic Advising Office. As a rule, documentation is required for academic consideration.

(ii) Academic consideration through an undocumented absence

Students are permitted one academic consideration request without supporting documentation per term per half-course (0.5) weight.

- Note that instructors may designate one assessment per half-course weight as requiring formal supporting documentation. Please refer to the course outline to confirm this assessment.
- If instructors have built flexibility into their assessments, this flexibility will already address consideration needs. (For example, if students need to submit X of Y assignments, this flexibility already provides consideration.)
- Undocumented absences can not be used as the basis for academic consideration for December or April exams.

c) Absences from Final Exams

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred.
