Course Objectives

This course analyzes the core topics of consumption, production, and their interaction in competitive markets. The course will make extensive use of diagrams and stress the intuition of results. The course is more advanced and mathematically more rigorous relative to Econ 2150, so you must be prepared for some mathematical analysis involving the use of calculus.

Learning outcomes

By the end of this course, you will be able to:

- apply economic theory to explain rational consumer decisions
- apply economic theory to explain producer decisions
- solve basic optimization problems
- develop an understanding of key forces affecting functioning of markets
- develop skills in modeling, critical thinking, and formal analysis using economic models.

Math Quiz

Math quiz administered and hosted by the School of MEM. Students will write 2000-level version of the quiz. To earn credit, you must score above 50%. You have two scheduled opportunities to take it:

If you miss both attempts due to uncontrollable circumstances, you can apply for an approved make-up. Upon approval, you may select an available Friday make-up time on September 25 or October 9. No further exemptions or extensions will be granted beyond the make-ups.

In-Class Assignments

In-class assignments will be delivered during lectures through iClicker. Short periods of lecture will be devoted to considering specific questions with the goal of solidifying and deepening the understanding. Your two lowest submissions will be dropped. This allows for short absences throughout the term, and there is **no academic consideration** for additional missed assignments outside of exceptional circumstances.

Online Homework

Each chapter will have associated homework questions to improve your understanding of course material. These questions will be available via Achieve and repeatable but must be done by 11:55PM on the assigned due date (mostly Sundays). Your final grade will be determined by your best score on each assignment and your lowest score will be dropped. Additional details and instructions will be posted on course website. There is **no academic consideration** for additional missed assignments outside of exceptional circumstances.

Exams:

Midterms will be held during regularly scheduled lecture times. A final exam will be held on the official date scheduled by the university. All exams might include multiple-choice and short-answer questions; the final exam is cumulative. Students who miss midterm 1 will require documentation that is approved by academic counselling to write the make-up. **The make-up date is October 29th**. Students will incur a fee of \$45.00 per make-up assessment booked with the Exam office. Students who miss the makeup exam will have the weight transferred to the final exam. There is **no makeup midterm 2**: if you cannot take midterm 2 at the scheduled time, your

grade will be re-weighted towards the final exam, so the final exam will count for 60% of the grade. *If you are struggling, please meet with me EARLY in the semester for assistance and feedback.*

Attendance, Rules and Expectations:

I expect that you will actively participate during class discussions. Please do not hesitate to ask questions in class and during my office hours. Remember: there are no bad questions!

You must adhere to the following rules:

- Arrive on time for class.
- Treat each other with respect and work cooperatively on in-class assignments.

1. Academic Accommodations, Consideration for Absences

Academic Accommodation (Accessibility)

Academic Consideration for Student Absence

If a student is unable to meet a course requirement due to substantial but temporary extenuating circumstances (medical or compassionate), they should follow the procedures below.

Absences from Final Examinations

If you miss the Final Exam, contact the Academic Advising Office of your faculty/college of registration as soon as you are able to do so. They will assess your eligibility to write the Special Examination (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a “Multiple Exam Situation” (e.g., more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred.
