This course examines major revolutions and 'turning points' that changed history. Topics include the Renaissance and Reformation, the Scientific Revolution, the Industrial Revolution, and the 'Sexual Revolution' of the 1960's. Political revolutions to be studied include the American and French Revolutions, and 20th century revolutions in China, Russia and Iran.

Revolutions in World History

Description: This course examines major revolutions that changed history. The course is structured into three units that examine: the origins of revolutions and their consequences; the global dimensions of revolutionary ideas and movements; and revolutions in science, medicine and technology. Specific topics will include revolutions in France and the Americas in the 1700s-1800s, the Industrial Revolution, the Sexual Revolution of the 1960s, and the civil and human rights movements of the 20th and 21st centuries.

Course Learning Outcomes:

By the end of this course students will be able to:

- define “revolution” and place it within various historical contexts
- identify and explain the historical significance of key ideas, events, people, and movements
- appreciate general trends over time in the study of revolutions and their outcomes
- be more civic-minded citizens with understanding of geopolitical realities
- demonstrate skills in critical analysis, research and writing for future study and employment

Readings:

There are no required textbook purchases for this course. However, students are required to read assigned articles, which are available on Brightspace. You will be tested on those readings.

Method of Evaluation:

Historical Concepts Assignment	15%	1 October 2026

Historical Concepts Assignment (15%): Students will complete a short in-class written assignment that asks them to define key course concepts, compare competing definitions from the course readings, and apply those definitions to one historical example discussed in class.

Tutorial Participation (20%): Students are expected to attend and actively participate in weekly tutorials based on the assigned course readings. Participation will be evaluated on the quality of each student's contributions rather than the quantity. Students are expected to demonstrate that they have completed the assigned readings, contribute thoughtfully to discussions, listen respectfully to others, ask relevant questions, and engage constructively with peers and the course material. Regular attendance is expected.

Document Analysis (30%): This assignment will be completed over two class sessions. In the first class, students will analyze a primary source by responding to a series of guided questions focused on historical context, audience, purpose, evidence, and interpretation. Feedback will be provided. In the second class, students will receive a second primary source on the same historical topic and complete a second analysis that incorporates comparison and reflection, demonstrating how new evidence can reinforce, challenge, or refine historical interpretations. All work must be completed during class.

Final Exam (30%): This is the three-hour cumulative final exam. It will be scheduled by the Registrar's Office and be written during the exam period in December 2026.

Please note, Friday Make-Up Exams may only be written with the instructor's consent.

1. Academic Accommodations (Accessibility)

2. Academic Consideration for Student Absences

Students must be approved to write a makeup exam or for an extension of the assignment deadline. If you need to miss an exam or the deadline for the assignment, please follow these instructions.

There are two ways to seek academic consideration:

(i) Academic consideration based on medical or compassionate grounds

If a student is unable to meet a course requirement due to substantial but temporary extenuating circumstances (medical or compassionate grounds), they should contact the Academic Advising Office. As a rule, documentation is required for academic consideration.

- Requests must be made as soon as possible, and no later than 48 hours after the missed assessment.

(ii) Academic consideration through an undocumented absence

Students are permitted one academic consideration request without supporting documentation per term per half-course (0.5) weight.

- Note that instructors may designate one assessment per half-course weight as requiring supporting documentation. Please refer to the course outline to confirm this which assessment has been designated as requiring documentation for consideration (that is, exempt from undocumented absences).
- Undocumented absences can not be used as the basis for academic consideration for December or April exams.

If an instructor has built flexibility into their assessments (e.g., “complete 8 of 10 quizzes”), this flexibility will already address consideration needs and thus academic consideration may be denied.

c) Absences from Final Exams

If you miss the Final Exam, **contact your Academic Advising Office** as soon as you are able to do so. They will assess your eligibility to write the “Special Examination” (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a multiple exam situation (i.e., you are scheduled to write more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred. Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

7. Copyright of Course Material

Faculty members are the exclusive owner of copyright in those materials they create. Students may take notes and make copies for their own use.
