Description: This course provides an overview of the development of medicine from antiquity to the present, including the growth of the medical sciences, concepts of disease, therapies, and the history of medical practice and institutions. We will approach the subject both chronologically and thematically, focusing on several major themes: anatomy, physiology, pharmacology, surgery, technology, epidemic diseases, medical ethics, and global health.

Learning Outcomes:

By the end of this course, students will be able to

- Describe the major developments in medicine from antiquity to the present, including changing understandings of disease, the body, and medical practice.
- Analyze how social, cultural, political, religious, and scientific contexts have shaped medical knowledge, healthcare, and public health across time.
- Evaluate the historical significance of key individuals, ideas, institutions, technologies, and epidemics in the development of medicine.
- Compare competing historical approaches to medicine and explain how medical theories and practices have changed over time and across societies.
- Demonstrate critical thinking by interpreting historical evidence and constructing clear, evidence-based arguments in written assessments.

Readings: There are no required textbook purchases for this course. However, students are required to read assigned articles, which are available on Brightspace. You will be tested on those readings.

Please note, Friday Make-Up Exams may only be written with the instructor's consent.

You will have two midterms during class-time that will consist of short answer and essay-style questions and will cover all course materials up to that point, including assigned readings, lectures, and in-class discussions. The purpose of the midterm is to assess your understanding of key concepts, themes, and arguments introduced in the course, as well as your ability to critically analyze and synthesize information across different sources.

You can expect a combination of short answer and essay-style questions, and you must

- Demonstrate knowledge of key texts, thinkers, and themes;
- Draw on lecture content and tutorial discussions;
- Make clear, well-organized arguments supported by evidence from the course

You will be given more details on the structure and expectations closer to the date. The exam will take place in-person and must be completed individually and without outside sources unless otherwise specified. Strong preparation will include keeping up with readings, reviewing lecture notes, and actively participating in tutorials.

The final exam will follow a format similar to the midterm, consisting of short answer and essay-style questions, but it will cover the entire course — including all assigned readings, lectures, and in-class discussions from the beginning of the term to the end. The final is designed to evaluate your ability to recall and explain key concepts, themes, and arguments from across the course, analyze ideas from multiple sources, and make-clear, well-supported arguments that reflect critical engagement with the material. Like the midterm, the final will be completed in-person, individually, and without external sources unless otherwise specified. Strong performance will reflect consistent engagement with the course over the term.

1. Academic Accommodations (Accessibility)

2. Academic Consideration for Student Absences

Students must be approved to write a makeup exam or for an extension of the assignment deadline. If you need to miss an exam or the deadline for the assignment, please follow these instructions.

There are two ways to seek academic consideration:

(i) Academic consideration based on medical or compassionate grounds

If a student is unable to meet a course requirement due to substantial but temporary extenuating circumstances (medical or compassionate grounds), they should contact the Academic Advising Office. As a rule, documentation is required for academic consideration.

For academic consideration requests on medical grounds, the Student Medical Certificate (SMC) is the appropriate documentation. The SMC is available at <https://registrar.uwo.ca/academics/pdfs/student-medical-certificate.pdf>

- If your home faculty is Huron or at Western, please submit your documentation to your faculty's academic counselling office.
- Requests must be made as soon as possible, and no later than 48 hours after the missed assessment.

(ii) Academic consideration through an undocumented absence

Students are permitted one academic consideration request without supporting documentation per term per half-course (0.5) weight.

- Note that instructors may designate one assessment per half-course weight as requiring supporting documentation. Please refer to the course outline to confirm this which assessment has been designated as requiring documentation for consideration (that is, exempt from undocumented absences).
- Undocumented absences can not be used as the basis for academic consideration for December or April exams.

If an instructor has built flexibility into their assessments (e.g., “complete 8 of 10 quizzes”), this flexibility will already address consideration needs and thus academic consideration may be denied.

c) Absences from Final Exams

If you miss the Final Exam, **contact your Academic Advising Office** as soon as you are able to do so. They will assess your eligibility to write the “Special Examination” (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a multiple exam situation (i.e., you are scheduled to write more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred. d) Religious Accommodations

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

7. Copyright of Course Material

Lectures and course materials, including PowerPoint presentations, tests, outlines, and similar materials are protected by copyright. Faculty members are the exclusive owner of copyright in those materials they create. Students may take notes and make copies for their own use. Students may not allow others to reproduce or distribute lecture notes and course materials publicly (whether or not a fee is charged) without the express written consent of a faculty member.
