DESCRIPTION:

What makes us human persons and how can we form meaningful social bonds, especially in times in which loneliness, alienation, and social isolation appear endemic? Early 20th century phenomenology maintains that specific forms of social relationships are fundamental for experiencing and understanding ourselves as human persons. This course consists of a study and discussion of the nature of subjectivity and its intimate connection to community in the philosophies of Edmund Husserl, Edith Stein and Max Scheler. Themes to be investigated include: the nature of the experience of community, the role of the body and gender in constructing community, time and affectivity, subjectivity and intersubjectivity, history and culture. Students will inquire into the nature of social consciousness through a phenomenological analysis of meaning or sense-building and lived experience.

The objectives of the course are:

1. To familiarise students with the work and ideas of phenomenologists like Edmund Husserl, Max Scheler and Edith Stein, especially their ideas about forms of sociality and communal life;

2. To develop tighter analytical and critical skills in thinking, reading and writing.
3. To assist students in developing their own philosophical responses to the questions and problems posed by the aforementioned philosophers' thought.

METHOD:

This course will proceed in a lecture-discussion format. Students are expected to read assigned texts and come prepared to discuss them in class.

EVALUATION:

1 small in-class reading exercise—3–5 pp. (15%) (done in class October 6, 2026)
1 research paper—12–15 pp. (35%) (Due in class December 8, 2026)
Final examination—(40%) (Date tba by the Registrar's Office)
Class participation—10%

There are two ways to seek academic consideration:

(i) Academic consideration based on medical or compassionate grounds

If a student is unable to meet a course requirement due to substantial but temporary extenuating circumstances (medical or compassionate grounds), they should contact the Academic Advising Office. As a rule, documentation is required for academic consideration.

(ii) Academic consideration through an undocumented absence

Students are permitted one academic consideration request without supporting documentation per term per half-course (0.5) weight.

- Note that instructors may designate one assessment per half-course weight as requiring formal supporting documentation. Please refer to the course outline to confirm this assessment.
- If instructors have built flexibility into their assessments, this flexibility will already address consideration needs. (For example, if students need to submit X of Y assignments, this flexibility already provides consideration.)
- Undocumented absences can not be used as the basis for academic consideration for December or April exams.

c) Absences from Final Exams

You may also be eligible to write the Special Exam if you are in a multiple exam situation (i.e., you are scheduled to write more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred.
