It undertakes systematic comparisons of political developments and institutions while providing students with an introductory look at the character of national political life in a variety of areas of the world.

Course Description: This course introduces students to the major themes, concepts, issues, and methodologies in comparative politics. The main objective of the course is to help students develop the analytical and critical skills to understand and study comparative politics systematically and to prepare students who wish to undertake more advanced courses in political science as well as in comparative politics. Comparative politics is a diverse field that includes the study of the state, democracy, political institutions, regime-types, social movements and revolutions, power, conflict, and nationalism across and within countries. Comparativists ask general questions, such as: What are the causes of democracy and dictatorship? What explains the resilience of authoritarian regimes? The field also asks more specific questions, such as: What accounts for democratic transitions in some countries but not others? What explains the persistence of authoritarian regimes in the Middle East?

Course Objectives:

By the end of this course, students will be able to:

- Develop an understanding of the core theories and methods in comparative politics;
- Develop an understanding of the key political institutions and regime-types such as the state, democracy, and authoritarianism;
- Understand and explain how political parties, electoral systems, identity, and interest groups shape and influence institutions and electoral outcomes;
- Compare and contrast countries, institutions, political actors by using the theories and methods covered in the course;
- Develop the ability to critically assess these ideas and information and to clearly communicate your knowledge in written and oral form.

Tutorial:

Attendance at weekly tutorial sessions is *strongly recommended* for success in the course. One-third of the tutorial grade will be determined by your attendance and the remainder by your active and engaged participation. Tutorials will provide students with the opportunity to ask questions, make comments, and discuss the lecture and readings. Tutorial activities will include debates, group discussions, group assignments, and other tasks. To receive full credit for participation, students must not only regularly attend the discussion section but also have completed the reading assignments for that week and actively participate in the discussion. Students are expected to participate in a constructive and respectful manner. Please refer to 'King's Code of Student Conduct' (available on our OWL site) for additional guidance on classroom expectations.

Research Paper Outline:

Detailed instructions for the assignment will be provided during class time on September 9, and additional documents will be shared on the course website.

Midterm Test:

The midterm test will cover material from readings, lectures, and tutorial discussions. The midterm test will be in-person during regular class hours. (The makeup date for the midterm test will be Friday, November 20, 2026.) Please note, Friday Make-Up Exams may only be written with the instructor's consent.

Research Paper:

Each student will be assigned to a country on which they will be expected to conduct research and produce a research essay on the state of democracy in the country. The aim of the essay is for students to identify and analyze the primary challenge(s) to democracy in the country that is

assigned to you. Papers must be between 1,500-2,000 words in length, double-spaced, not counting appendices, the compulsory title page, and bibliography. The paper must be formatted in Times New Roman or Calibri 12pt font with 2.54 cm margins all around. Papers that do not meet these basic criteria will be penalized. Students must conduct research with a **MINIMUM of 10 references**. Of these, reference at least four relevant articles from academic journals and at least one book. Note that while such sources as current affairs magazines (Economist, Foreign Policy, etc.) or media sites (CBC, CNN, BBC, etc.) are informative, they are different from academic peer-reviewed journals. Students must avoid using Wikipedia – it may be useful to get a quick overview of a topic, but it is not always reliable and therefore must be avoided. Further instructions and detailed guidelines will be posted to Brightspace. Papers that do not meet these basic criteria will be penalized. Detailed instructions will be made available on the first day of the course.

Research Paper Presentation:

Students will be expected to share their research paper findings with the instructor and fellow students in the form of a brief (5-8 minute) presentation near the end of the term during class time. Additional details and information will be provided to students in the second half of the term.

Final Exam (December 2026):

The final exam will take place during the Final Exam Period in December 2026. The final exam will be in-person on a date and location to be determined by the University.

Academic Offenses and Plagiarism:

Scholastic offenses are taken seriously, and students are directed to read the University policy on plagiarism.

All written assignments must be submitted in electronic format to the plagiarism checking website Turnitin.com (available through the course website and under license to the University). Please be advised that: All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between the University of Western Ontario and Turnitin.com.

The use of Artificial Intelligence (AI) software on any course assignments is not permitted unless explicitly authorised in advance by the instructor. When writing the research paper, the use large language models (LLMs) should be supplemented with an appendix with the entire exchange(s) with the LLM. Students are expected to write a narrative at the beginning of the appendix explaining precisely how they used the LLM (e.g., to generate ideas, turns of phrase, elements of text, long stretches of text, lines of argument, pieces of evidence, etc.). This narrative should also explain why they used the LLM (e.g., to save time, to overcome writer's block, to clarify prose, etc.).

Late Policy:

Read carefully: Written assignments must be submitted by the deadline by 11:59PM. If you fail

to meet this deadline, your assignment will be considered late. Late assignments will receive a penalty of 15%. Late assignments are then due the following week by 11:59PM. After that, the assignment will not be accepted and will receive a grade of zero.

Extensions will be granted ONLY under the following circumstances:

- (1) Humanitarian grounds (e.g., in the case of death or serious illness in the family);
- (2) Medical grounds.

In each circumstance, you will be expected to provide documented evidence. A copy of which may also be submitted to the Academic Dean's Office.

1. Academic Accommodations (Accessibility)

Accessibility Services works to ensure that academic programs are accessible to all students, and supports students who may have a condition related to, but not limited to, vision, hearing, mobility, different ways of learning, mental health, chronic illnesses, chronic pain, autism spectrum disorder, ADD/ADHD, and temporary conditions (beyond short-term academic consideration). 2. Academic Consideration for Student Absences

Students must be approved to write a makeup exam or for an extension of the assignment deadline. If you need to miss an exam or the deadline for the assignment, please follow these instructions.

There are two ways to seek academic consideration:

(i) Academic consideration based on medical or compassionate grounds

If a student is unable to meet a course requirement due to substantial but temporary extenuating circumstances (medical or compassionate grounds), they should contact the Academic Advising Office. As a rule, documentation is required for academic consideration.

For academic consideration requests on medical grounds, the Student Medical Certificate (SMC) is the appropriate documentation. The SMC is available at <https://registrar.uwo.ca/academics/pdfs/student-medical-certificate.pdf>

- If your home faculty is Huron or at Western, please submit your documentation to your faculty's academic counselling office.
- Requests must be made as soon as possible, and no later than 48 hours after the missed assessment.

(ii) Academic consideration through an undocumented absence

Students are permitted one academic consideration request without supporting documentation per term per half-course (0.5) weight.

- Note that instructors may designate one assessment per half-course weight as requiring supporting documentation. Please refer to the course outline to confirm this which assessment has been designated as requiring documentation for consideration (that is, exempt from undocumented absences).
- Undocumented absences can not be used as the basis for academic consideration for December or April exams.

If an instructor has built flexibility into their assessments (e.g., “complete 8 of 10 quizzes”), this flexibility will already address consideration needs and thus academic consideration may be denied.

c) Absences from Final Exams

If you miss the Final Exam, **contact your Academic Advising Office** as soon as you are able to do so. They will assess your eligibility to write the “Special Examination” (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a multiple exam situation (i.e., you are scheduled to write more than 2 exams in 23-hour period, or more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred.
