Course Information

Course Description: An examination of statistical issues aiming towards statistical literacy and appropriate interpretation of statistical information. Common misconceptions will be targeted. Assessment of the validity and treatment of results in popular and scientific media. Conceptual consideration of study design, numerical and graphical data summaries, probability, sampling variability, confidence intervals and hypothesis tests.

Achieve is an online service provided by the textbook publisher, offering a range of resources such as supplementary videos, online applets, tutorials, and extra practice problems. These tools are especially helpful for reinforcing challenging concepts. All course quizzes will be administered through Achieve. Therefore, students will need a stable high speed internet connection for this course.

Please note that if you purchase a second-hand textbook, you must buy a separate subscription to Achieve from the publisher's website, as the access code cannot be transferred from the original owner.

Mode of Instruction

This course will have in person instruction. It will be a lectured course where student will be expected to take lecture notes. Annotated notes will not be posted.

Assessments

You will need a pocket (non-programmable) calculator for course assessments.

Textbook Exercises (not graded)

A schedule of topics and recommended textbook exercises are provided in this course outline (see below). Although these exercises are not graded, they offer excellent practice and will be beneficial for your learning and preparation for quizzes and tests. Instructor solutions to the textbook exercises can be found on OWL.

A) Online Progress Quizzes in ACHIEVE

There will be **4 open-book quizzes** administered through **ACHIEVE**. The quizzes are to be written within the following 48-hour date windows, 6:00 p.m. on Thursday to 6:00 p.m. (*EDT*, eastern daylight time) on Saturday:

- Quiz 1 is available from 6:00 pm, Thursday, Sept. 24 to 6:00 pm, Saturday, Sept 26
- Quiz 2 is available from 6:00 pm, Thursday, Oct. 22 to 6:00 pm, Saturday, Oct. 24
- Quiz 3 is available from 6:00 pm, Thursday, Nov. 5 to 6:00 pm, Saturday, Nov. 7
- Quiz 4 is available from 6:00 pm, Thursday, Nov. 26 to 6:00 pm, Saturday, Nov. 28

Each quiz will consist of between 8 to 10 multiple-choice / fill in the blank style questions and will be cumulative. Students will have 1 hour to complete each quiz, with 2 attempts allowed per question, and the highest score recorded. Quiz grades will be available in Achieve after the quiz deadline. These are open book/notes quizzes, but they must be completed independently.

Please note that there is no accommodation for missed online quizzes as accommodation is already considered within the marking scheme (best 3 of 4).

B) Midterm Exam

There will be a 2-hour midterm exam for this course. Topics for the exam will be announced in advance through OWL. The format of the midterm exam will be a multiple-choice examination or a combination of multiple choice and short written answer questions.

- **Midterm, Oct. 30, Friday, 7:00 pm to 9:00 pm, room TBA**

Academic consideration for this midterm exam requires submission of formal supporting documentation. Students who miss the midterm will need to obtain academic accommodation to write the make-up exam. If the reason is not deemed valid, a mark of 0 will be applied. If the reason is deemed valid, the make-up exam will take place on Friday, Nov. 6, 2026. Students who miss the makeup with academic consideration will have their midterm reweighted to the final exam. There are no additional midterm makeup opportunities for any reason.

C) Final Exam

The final exam will be a three-hour cumulative multiple-choice examination or a combination of multiple choice and short written answer questions. A formula page will be provided. It will be scheduled by the Registrar's office (During the Examination period Dec. 11 – Dec. 22, 2026).

D) Religious accommodations

Students seeking religious accommodations for any coursework must make such requests to academic counselling at least one week in advance (and at least two weeks in advance for final exams). After academic counselling has been contacted, you must then notify your instructor.

E) Use of artificial intelligence (AI)

Within this course, use of artificial intelligence (AI) tools such as Chat GPT is not permitted for quizzes, tests, and exams submitted for evaluation. Evaluation

Your course grade will be determined using the following marking scheme:

*Float Weight	5

*The float weight worth 5% will be applied to a student's highest grade from the midterm exam or the Final Exam. For example, if a student obtains 75% for midterm and 80% for the final exam, then the final exam will be worth 45%+5% of the course grade for that student. If a student obtains 80% for midterm and 75% for the final exam, then midterm will be worth 35%+5% of the course grade for that student.

A formula sheet and statistical tables will be provided at the midterm exam and final exam.

Due to the flexibility of the marking scheme, there is no make-up for any reason for missed quizzes. Accommodation is already considered within the marking scheme.

For reference, the following are Western's university-wide grade descriptors:

- A+ 90-100 One could scarcely expect better from a student at this level

Learning Outcomes and Course Objectives

The course provides an introduction to statistics. By the end of the course students should have a basic understanding of:

- the techniques used in exploring, organizing and describing data;
- producing data through surveys and experiments.
- the basic concepts of statistics (define, explain, and use these concepts)
- the basic concepts of probability and distributions (define, explain, and use these concepts)
- statistical inference: including confidence interval construction and tests of hypotheses.

Attendance Policy

Attendance is required. Missing 30% of scheduled classes is considered to be too frequent. A warning email may be issued at the 25% point and if absences continue the instructor will implement the King's attendance policy below:

1. Academic Accommodations, Consideration for Absences
